U.S. Army Combat Capabilities Development Command Chemical Biological Center

The U.S. Army Combat Capabilities Development Command (DEVCOM) Chemical Biological Center is the nation's principal research and development resource for non-medical Chemical and Biological (CB) Defense. As a critical national asset in the CB Defense community, DEVCOM Chemical Biological Center supports all phases of the acquisition life cycle from basic and applied research through technology development, engineering design, equipment evaluation, product support, sustainment, field operations and demilitarization to address its customers' unique requirements.

Aberdeen Proving Ground

Aberdeen Proving Ground (APG) is the Army's oldest active proving ground, and was established on October 20, 1917, six months after the United States entered World War I. It remains one of the Army's most active and diversified installations. Situated at the mouth of the Chesapeake Bay and bordered by the Susquehanna and Gunpowder Rivers, APG is surrounded by some of the best natural resources that Maryland has to offer. Located along the I-95 corridor, APG is approximately 74 miles driving distance to Philadelphia, 71 miles to Washington, D.C. and 32 miles to Baltimore.

Directions to Edgewood Area of APG

From Baltimore:

- I-95 North to Exit 77A (MD Route 24 South).
- Proceed approximately 4 miles to the Edgewood Area gate.

From Delaware:

- I-95 South to Exit 77A (MD Route 24 South).
- Proceed approximately 4 miles to the Edgewood Area gate.

From BWI Airport:

- I-95 West
- Exit 2A, MD 295 North (Balti-Wash Parkway) toward 1-695 Baltimore.
- Take I-895 Harbor Tunnel Exit
- I-895 Harbor Tunnel merges with I-95 North.
- I-95 North to Exit 77A (MD Route 24 South).
- Proceed approximately 4 miles to the Edgewood Area gate.

Directions to DEVCOM Chemical Biological Center Buildings

From Gate to Building E3330:

- Turn left at first traffic light onto Magnolia Rd.
- Follow Magnolia Rd. (becomes Ricketts Point Rd.) around airfield.
- Continue straight; E3330 will be on your left, parking on your right.

From Gate to Building E3549 (Berger Building):

- Turn left at first traffic light onto Magnolia Rd.
- Follow Magnolia Rd. (becomes Ricketts Point Rd.) around airfield.
- Continue Straight and turn left into parking lot entrance.

From Gate to Building E3150 (McNamara Building):

- Turn left at first traffic light onto Magnolia Rd.
- Follow Magnolia Rd. (becomes Ricketts Point Rd.) around airfield.
- Turn Left onto North Kings Creek Rd.
- Continue straight until you reach E3150.

From Gate to Building E3400:

- Turn left at first traffic light onto Magnolia Rd.
- Follow Magnolia Rd. (becomes Ricketts Point Rd.) around airfield.
- Continue straight; E3400 will be on your right.

Entrance to APG

Visitors **with** a valid Government ID (CAC or other ID) may stop and entrance and present guard with ID.

Visitors **without** a valid Government ID (CAC or other ID) need to have a visitors pass. To obtain one, stop at the Visitors Building on the right and present a valid photo ID and car registration at the desk.

- All vehicles are subject to inspection.
- No cameras or photography are permitted at any gates.
- Visitors must use hands-free phones while driving on APG.

Citizenship Requirements

Only U.S. citizens are permitted area access without Foreign Disclosure approval (minimum of 2 weeks notice required for processing.) Dual citizens are considered foreign nationals.

Security Requirements

Visitors should contact their point of contact at least 48 hours prior to arrival.
